13. Minutes

It was proposed by Cllr Vigar and seconded by Cllr Bessant, with all in favour, it was **RESOLVED:** to accept the Environment & Planning committee minutes held on 7th June 2022.

14. Chairman's report (As attached)

Cllr. Gibson standing in for the chair outlined the main points from the report which is attached to these minutes.

15. Great Big Green Week Events (GBGW) (Schedule attached)

Cllr Gibson outlined the events in the schedule, which is attached.

Cllr Vigar mentioned that there is a low cost/low carbon Recipe Book being produced with the proceeds from sales being donated to the skatepark.

16. Residents' Panel: Environment-Focused feedback from May results

At the request of the Community and Wellbeing Committee held on 28th June 2022 the environmental aspects of the Residents panel were shared it was noted that this panel had an improved response rate, 79/100.

17. Green Space update

The Green Spaces Officer provided a verbal update on the recent Southwest in Bloom judging, which included a walking tour from the cemetery into the town centre, explaining the result would be announced in October.

Updated that the tree grant works would happen over the winter period, starting in December. He also confirmed that following an audit of the litter bins, ten would be replaced by the end of the financial year, with dual, waste and recycling bins.

He also reported that volunteer capacity was slowly building, particularly in the country park.

18. Living Wall

Cllr Gibson reported that the wall was in the process of being built and should be completed by Thursday 28th July. Stating it had been a long time coming and congratulating all involved.

Stephanie Edwards from the public congratulated the committee, Cllr Kay and Councillor officers for seeing this project to completion.

19. Lighting Strategy

The finalised draft report was presented to members, a couple of minor typos were noted, and it was proposed by Cllr Gibson and seconded by Cllr Franklin, with all in favour, it was <u>RESOLVED</u>: to adopt the Lighting Strategy.

20.Play Areas

The first meeting of the new Working Group was held today, 26th July 2022, the Director of Operations reported that the working group would break the work into two streams, i) looking at the priorities and ii) looking at the individual areas at the point of repair/replacement.

Cllr Bessant reminded the committee of the need for a landscape plan for Poulton Field to ensure the skatepark, tree planting, paths and play areas were planned and it was agreed that the officers would discuss this with the Chair on her return and update t next meeting.

Appendix 1

Members of the public who spoke at the Environment & Green Spaces Committee on the 26th July 2022

Kate – Is the council aware that Himalayan Balsam is in the town.

CH: This is an invasive plant along the river, the Wiltshire Wildlife Trust have some grant funding. They are expected in the town on 9th August 2022 and the following two Tuesdays.

Liz – Enquired about the pricing of charity stalls at the Thursday market. The charge is £20, the RSPB man has said this is the highest charged rate that he is aware of.

Gillian – Is there a facility for people to drop of apples etc. there is the opportunity to have a community 'juicing'.

The community fridge was mentioned as a suitable drop off point.

Andrew – Lighting strategy doesn't have a text layer which means its inaccessible for blind people, which is breaking our policies, and this has been the case with other documents, agendas, and minutes in recent months, I have raised this before. Is there an IT programme that I don't know about that is underway that is going to fix this and when can we all access all the agendas and minutes for all previous meetings.

Neighbourhood plan 2013 -2026 was adopted in 2017 which is about 4 1/2 years after it started, if we want a plan to be ready for 2022 – 2035 we need to start working on its this year. Has the council the intention, bearing in mind the four-year lead time.

Lighting strategy, I think is a start, too bog standard, doesn't have high enough aspirations. Can we take the lighting strategy as a point of departure when we frame policies in our next Neighbourhood plan in responding to the bio-diversity emergency.

Jeremy – Lighting strategy the search box opens but doesn't seem to work, section 2.6 has an error.

Alex Kay, Environment & Greenspaces Chairman's report for Tuesday 4/10/22

- 1. Attack on Nature! Many environmental groups, including RSPB, Wildlife Trust, National Trust, Council Protection of Rural England, have reacted angrily and strongly spoken out against the Government's devastating plans to remove protection from vast swathes of our countryside. They say this is an unprecedented attack on Nature. These groups represent millions of members across political parties. They are mounting campaigns to reverse this plan. We have a responsibility to nature and attempt to reverse the trend in biodiversity and we have come to know much more, during COVID, the value to our own well-being of all green spaces. The latest mini-budget does nothing for the environment in the year when the UK government presides over COP and soon will attend COP27 in Sharm El-Sheik. Make your voice heard for nature.
- 2. **Community Fridge is now open!** 9am-5pm 7 days/week; stocked primarily from CoOp. No abuse or problems so far. Permanent sign in place.
- 3. **CF Sustainable** Food Group meeting 20th July: Material finalised for businesses incl. Fair-Trade and Plastic-free, but is now designed as a sustainability improvement plan. Volunteers delivering to business during GBGW. Excellent work from Ros and her team, and especially to Maureen Breeze from the CoOp.
- 4. SW in Bloom judging day: 12th July. Awaiting results.
- 5. **Great Big Green Week Planning**: 24/09-02/10 wide range of events and exhibitions arranged for venues across BoA; AK & Climate Friendly. Including follow Domestic Heating Event and Eco-Fair highlighting biodiversity. Including several radio interviews BBC Wilts and Bath radio.
- 6. **Bradford on Avon Rowing & Kayak Club:** river litter clean-up 30th July between Avoncliff and Town weirs.
- 7. Living Green Wall: Official Opening of the completed wall 29th July. A lot of positive media interest.
- 8. **Tithecote Manor:** preliminary discussions with residents about poor state of the green space, 15th Sept with GSO.
- 9. **Playgroup working group:** several meetings to help develop way forward to maintain and improve play areas. Report in meeting.
- 10. **Other projects:** green space entry gates and parking control; community compost (possibly launched during GBGW); tree planting and volunteers; healthy river.
