#### 01. Minutes

It was proposed by Cllr Vigar seconded by Cllr Bessant and with 5 in favour and 2 abstentions it was **RESOLVED**: To accept the minutes from the last meeting dated 22<sup>nd</sup> March 2022 as a true record.

02. Matters arising - none

#### 03. Declarations of interest

Chairman declared he was a member of the cricket club.

#### 04. Chairman's Report

Chairman reported he had attended a Christmas lights meeting, which would happen at the end of November with exciting plans developing with local musicians and including the Lamb Yard location.

05. <u>Neighbourhood Plan Working Group</u> Councillors would be picking this up at the conference on Monday 16<sup>th</sup> May 2022.

06. <u>Delegated recommendations</u> Delegated decisions for 16<sup>th</sup> and 30<sup>th</sup> March 6<sup>th</sup> and 20th April and 4<sup>th</sup> May 2022 were noted.

#### 07. Culver Close Community Pavilion

The Chairman stated that this was covered in great detail during the public question section of the meeting. Also explaining that consultation events had taken place, there had been lots of correspondence and a meeting immediately prior to this Town Development meeting. He explained that the Council was currently waiting for Wiltshire Council's Planning and Conservation Officers to come back to arrange a discussion on the current design.

The chairman confirmed that there would be further consultation and Cllr Vigar also pointed out the Town Development Committee meeting dates, for the rest of the year, were on the website.

The chairman confirmed that the list of questions submitted previously would be answered as quickly as possible and that the Council would update as information became available.

The chairman summed up that he was hearing a lot of good ideas and wanted to commit to further consultation. That there was a general feeling of agreement of the need, but there will be further consultation and discussions before planning permission is sought.

#### 08. Skatepark at Poulton (standing item)

Cllr Bessant updated that the Council is having monthly working group meetings, with the next Thursday 12<sup>th</sup> May 2022. That the group were looking at ways to take the project forwards, looking at other organisations such as Skateboard UK to get funding. There is the possibility of a two-stage approach, build what we can afford now and then raise further. Currently looking at what funding vehicle would be best to set up to apply for grants.

#### 09. One Public Estate

Cllr Kay reported that there had been considerable discussions, however there is a re-organisation within the health centre which may change their requirements from the project. This has meant there is a delay while this is worked through. Cllr Kay also stressed that this a feasibility study.

#### 10. Old Golf Course Working Group

Cllr Potter reported that nothing had been received from the EA with regard to the waste on the site, nothing from the owner regarding the possibility of selling the site and that Wiltshire Council hadn't outlined what they wanted from the site.

#### 11. War Memorial

Director of Operations confirmed that the War Memorial Trust have granted £1,180 towards the costs of the works to the war memorial, total cost would be £2,350. The contractor is signing the method statement next week. The Trust were not willing to give a grant towards the restoration of the Canadian Airman plaque, due to it being less than 30 years old. The Trust also require prior approval of the new location if the Council were to move the plaque. It is intended to work with the Trust to agree a location to make the plaque more visible. However, this will not hold up the works to the memorial.

#### 12. Date of next meeting

The next meeting was arranged for the 12<sup>th</sup> July 2022.

#### 13. Confidential Business

It was proposed by Cllr Vigar seconded by Cllr Trimble and with all in favour it was **<u>RESOLVED</u>**: to start confidential business.





"It's hard to pin point specific areas but I would like some thought about areas where children are most likely to run around. Unfortunately rewilding seems to mean that dog owners are less likely to pick up mess in these areas so it's not very pleasant and a bit of a health hazard if done where children are likely to be running/crawling about"

"Rewilding needs to be where the seeds cannot destroy years of private gardening with invasive weeds. There are enough problems already with road edges no longer being cleaned"

"As many rewilded areas as possible, especially large areas of Barton Farm Country Parks. Consult with the nearest residents about particular patches of green areas. Rewild the grassy areas in 'Chruches'. Rewild road verges in line with Plant Life road verge guidance. Rewild the old golf course if you can (or encourage the owner to do so). Rewild bus shelter roofs with green roofs for pollinators. Rewild traffic islands with small wild flowers or herbs to improve the urban environment."

#### Standout comments

"Increasing the options at the Terracycle centre, for example we can't find anywhere to recycle Pet food sachets and this would be a great option (sure many others would use). Hoping the one way system introduction (please!!) will have the biggest impact on the climate issue directly in BOA with less idle traffic pollution and far superior pedestrianisation options making it a much cleaner, safer and pleasant town to walk and cycle around, rather than as is now, which would encourage in turn more footfall than car use."

"A 'Library of Things' would be useful. We do not all need (nor can many people afford) to own household items like a drill, lawnmower, sander, tall stepladder, power washer that gather dust for most of the year and only get used occasionally. If there was a resource in every town where you could book an item and then collect from a central point for a set amount of time, it would help reduce a lot of unnecessary manufacturing. People could also donate unwanted items like TVs and Microwaves here for people to take and keep. So often, perfectly serviceable items like this end up in landfill when a household decides to upgrade, because they cannot be donated to charity shops."

"I also think that more needs to be done to formally bring groups together to deal with specific issues, especially if this could encourage generational mixing. This town is half populated with time-poor families struggling to fit their myriad responsibilities into the week who for example would have little opportunity to grow their own vegetables; and half populated by people at a later stage of life who are more time rich, many of whom are very community minded/proactive about addressing ecological issues. How can we formally bring these groups of people together to help each other to do skills swops and take positive, practical action that would benefit us all? Are there people in the community who are very well informed about how to live in a greener way that could help to run how to

War Memorial report:

Bradford on Avon war memorial will benefit from a grant in 2022-23 of £1,180 from Grants for War Memorials scheme supported by Historic England.

Before the works can begin the War Memorial Trust (WMT) have asked some additional questions regarding the restoration works and the contractor is in the process of collecting the answers. Once the WMT are happy with our response the contractor is looking to start the works at the beginning of September and estimates they will take around 2-3 weeks to complete.

Regarding the "V for Victor" memorial plaque. The WMT are not willing to give a grant towards its restoration as it is only 28 years old. They are also not supportive of it being moved as they are concerned about the impact it will have on the main war memorial. I am currently in discussion with them, explaining the reasons behind wanting to move the memorial to a more prominent location. In the meantime, I have requested that we be allowed to go ahead with the restoration work to have the lettering re-painted.
